1. Call to Order - 1:40 PM, Chairperson Carol Hryniuk-Adamov

2. Welcome and Introductions

- 3. Voting privileges were noted to be the co-ordinator or designate from each province. (Names underlined in the attendance list above indicate individuals who carried a vote.)
- Minutes of Meeting held May 7, 2003 in Orlando, Florida. Errors noted in names (s/b Hnatiuk and Hryniuk) and amounts collected for CNIRAC breakfast in Orlando (s/b \$80 U.S.)

Motion: Garth/Meredith that the minutes be adopted as corrected. Carried

5. Financial Report - Current balance is \$241.13

Motion: Sandra/Garth that Shirley be reimbursed \$286.24 to cover the bill for the CNIRAC breakfast meeting in Orlando. Carried.

Motion: Sandra/Meredith that Garth be reimbursed \$5766.26 to cover the bill for the Canadian Reception in Orlando. Carried.

The Canadian Reception pledge forms (Eileen prepared these as per motion at May  $7^{th}$  meeting) were distributed to provincial co-ordinators. These forms should be distributed to all provincial associations and local councils in September.

#### Recommendations:

 Request deadline for submission of donation cheques for Canadian Reception to Eileen Froehlich by April 1, 2003.

- Treasurer's Report should reflect Canadian Reception donors and amounts as acknowledgement for their contributions.

Motion: Meredith/Robina that the financial report be accepted. Carried.

6. Regional Conference Profits: Shirley Choo reported approximate revenues as the audit and financial statements for the Regional Conference are not completed. CNIRAC will receive approximately 6% of the total profits (approximately \$4000).

Motion: Meredith/Lena that a budget committee be formed to set guidelines for the use of the profits from the Regional Conference and that Eileen Froehlich, Shirley Choo and Carol Hryniuk-Adamov serve on this committee. Carried.

7. Formation or Activation of Councils

NWT - Carol reported that they are working on charter in Yellowknife for a territorial council. Brenda Townsend stated that different forms were necessary for formation of territorial council. Carol is to contact NWT representatives and inform them that they will need to contact Brenda and fill out different forms.

Atlantic - Meredith will make contact in Nova Scotia later this summer. Shirley will review Regional Conference attendees for possible contacts. PEI - Meredith and Garth will try to contact Susan Elliot.
